Category: This is an Information Meeting with a Question and Answer Session. The purpose of this meeting is for the NRC staff to meet directly with individuals to discuss regulatory and technical issues. Attendees will have an opportunity to ask questions of the NRC staff or make comments about the issues discussed throughout the meeting; however, the NRC is not actively soliciting comments towards regulatory decisions at this meeting.

Purpose: The U.S. NRC is holding a public meeting to provide information about the issuance of the final NUREG-1757, Volume 2, Rev. 2, "Consolidated Decommissioning Guidance, Characterization, Survey and Determination of Radiological Criteria, Final Report." The technical guidance document provides information on dose modeling to derive clean-up levels and radiological surveys to demonstrate compliance with license termination rule criteria found in 10 CFR Part 20, Subpart E. Staff will be available to answer questions on revisions to the NUREG after a short NRC presentation.
