This letter documents the Nuclear Regulatory Commission (NRC) staff's plan to perform an inspection of the MPR Associates, Inc.'s Appendix B, "Quality Assurance Program Criteria for NuclearPower Plants and Fuel Reprocessing Plants," to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 50, "Domestic Licensing of Production and Utilization Facilities" quality assuranceand 10 CFR Part 21, "Reporting of Defects and Noncompliance," programs as they pertain to activities conducted at your facility related to engineering design services, software development, commercial-grade dedication services, and Basler excitation systems and associated components being supplied to NRC's regulated facilities. As discussed via electronic mail on January 5, 2023, the NRC inspection team plans to arrive at your facility on Monday, March 6, 2023, and will conduct an inspection through Friday, March 10, 2022.
