Title: Public Meeting on Regulatory Concepts for the Integrated Low-Level Radioactive Waste Disposal Rulemaking

Category: This is an Information Meeting with a Question and Answer Session. The purpose of this meeting is for the NRC staff to meet directly with individuals to discuss regulatory and technical issues. Attendees will have an opportunity to ask questions of the NRC staff or make comments about the issues discussed throughout the meeting; however, the NRC is not actively soliciting comments towards regulatory decisions at this meeting.

Purpose: The purpose of this public meeting is to discuss potential changes to Part 61 low-level waste disposal regulations to integrate criteria for licensing the near-surface disposal of greater than class C waste and to ensure that the low-level radioactive waste streams that are significantly different from those considered during the development of Part 61, such as depleted uranium, would continue to be disposed of safely.
