




LIC-500 - TOPICAL REPORT PROCESS

- The latest revision added 3 New Review Pathways to Increase Efficiency and Timeliness.
 - ✓ Compressed, Uncomplicated, and SE Confirmation Reviews
- Traditional Review Maintained
 - ✓ Standard Review (24 months)
- Process Efficiencies
 - \checkmark Shorter timelines
 - E-mail transmittals of RAIs, Draft and Final safety evaluation (SE), audits, four new NRC Forms (895-898).
 - Sponsor can suggest Pathway based on pre-submittal discussions, however, NRC makes selection.

Detailed Review	RAI questions or other options to get the desired information efficiently (e.g., audits, public meeting/conference call, requests for confirmation of information). Review Documentation	Draft SE, Final SE, and a -A TR with verification on NRC Form 896, "-A TR Verification Review Determination."	Draft SE, Final SE, and a –A TR with verification on NRC Form 896.
