Title: 10 CFR Part 26, Fitness for Duty Programs - Question and Answer Session on Implementing the November 2022 Final Rule

Category: This is an Information Meeting with a Question and Answer Session. The purpose of this meeting is for the NRC staff to meet directly with individuals to discuss regulatory and technical issues. Attendees will have an opportunity to ask questions of the NRC staff or make comments about the issues discussed throughout the meeting; however, the NRC is not actively soliciting comments towards regulatory decisions at this meeting.

Purpose: To provide licensees and other entities subject to 10 CFR Part 26 with another opportunity to ask the NRC technical staff questions on implementing the "Fitness for Duty Drug Testing Requirements" Final Rule, which was published in the Federal Register on November 22, 2022 (87 FR 71422). The NRC staff held a previous Information Meeting with a Question and Answer session on this topic on April 26, 2023. Licensees and other entities must comply with the final rule changes by November 22, 2023.
