Title: Preapplication Meeting with Arizona Public Service Company to Discuss Proposed Increases to TSs 3.5.1 and 3.5.2 Safety Injection Tank Nitrogen Cover Pressure Band for Palo Verde Nuclear Generating Station, Units 1, 2 and 3.

Category: This is an Observation Meeting. This is a meeting in which attendees will have an opportunity to observe the NRC performing its regulatory function or discussing regulatory issues. Attendees will have an opportunity to ask questions of the NRC staff or make comments about the issues discussed following the business portion of the meeting; however, the NRC is not actively soliciting comments towards regulatory decisions at this meeting.

Purpose: The purpose of this meeting between the U.S. Nuclear Regulatory Commission (NRC) and Arizona Public Service Company (APS, the licensee) is to discuss a planned license amendment request for Palo Verde Nuclear Generating Station, Units 1, 2, and 3, regarding increases to Technical Specifications 3.5.1, "Safety Injection Tanks (SITs) - Operating," and 3.5.2, "Safety Injection Tanks (SITs) - Shutdown," SIT nitrogen cover pressure band to reduce the challenges on the SIT vent valves. The discussion will include updates to the large break loss-of-coolant-accident evaluations; and containment pressure/temperature analyses including converting to the GOTHIC computer code from the no longer supported COPATTA code.
