Palisades Restart Panel



- Oversees regulatory activities
- Provides management for licensing and inspection activities
- Proactively identifies and promptly resolves any challenges regarding restart
- Focus on communications

Licensing Activities



- All expected licensing actions have been submitted and accepted for review
- Detailed technical review underway
 - Requests for additional information have been issued for some licensing reviews
- Environmental review has begun
- NRC staff will make efficient licensing decisions that ensure safety

Noticing Process



- License amendment requests and license transfers are noticed for comment and opportunity to request a hearing
- 2 Notices
 - License transfer: 30-day comment/ 20-day hearing request window
 - License amendments: 30-day comment/ 60-day hearing request window
- Notices to be published on August 7th

Potential Restart Inspection U.S.NRC and Assessment





- NRC regional inspectors have directly inspected restart activities
 - Licensed operator requalification program
 - Radiological hazards
 - Primary coolant system decontamination
 - Reactor vessel inspection



Potential Restart Inspection U.S.NRC and Assessment

- United States Nuclear Regulatory Commission Protecting People and the Environment
- Results of restart inspections are provided in publicly available quarterly restart inspection reports
- Resident Inspectors expected to start working at the site in late 2024
