Category: This is a Comment-Gathering Meeting. The purpose of this meeting is for NRC staff to meet directly with individuals to receive comments from participants on specific NRC decisions and actions to ensure that NRC staff understands their views and concerns.

Purpose: The purpose of this meeting is to discuss feedback that staff should consider as it is developing recommendations for updates to oversight in the radiation safety strategic performance area of the reactor oversight process (ROP). These updates are being considered in the context of SECY-25-0045 (ML25042A278), which describes a comprehensive review of the ROP in support of NRC regulatory reform initiatives. Meeting topics include information that inspectors can use to better risk-inform inspections (including existing data sources that can be used to assess performance in lieu of inspection effort); optimizing inspection resources (including the use of remote inspections when appropriate), potential updates to Performance Indicators and updates to other radiation safety-related inspection manual guidance (e.g., more-than-minor examples and significance determination processes).
