Title: Grants Energy - Pre-Application Meeting

Category: This is an Observation Meeting. This is a meeting in which attendees will have an opportunity to observe the NRC performing its regulatory function or discussing regulatory issues. Attendees will have an opportunity to ask questions of the NRC staff or make comments about the issues discussed following the business portion of the meeting; however, the NRC is not actively soliciting comments towards regulatory decisions at this meeting.

Purpose: On May 1, 2025, Grants Energy submitted a Letter of Intent (Agencywide Documents Access and Management System (ADAMS) No. ML25125A097) to the U.S. Nuclear Regulatory Commission (NRC), indicating their intent to apply for a license to construct and operate a Uranium In-Situ Recovery (ISR) facility near Grants, New Mexico. Representatives of Grants Energy are meeting with members of the NRC staff to discuss aspects of the project. This is a continuation of previous pre-licensing meetings discussions regarding the development Radiation Safety Program (RASP) for the Grants Energy Project.
