Title: Meeting with Duke Energy Progress, LLC to Discuss Proposed License Amendment Request for Shearon Harris Nuclear Power Plant, Unit 1

Date(s) and Time(s): January 07, 2026, 10:00 AM to 11:00 AM ET

Location: Webinar

Category: This is an Observation Meeting. This is a meeting in which attendees will have an opportunity to observe the NRC performing its regulatory function or discussing regulatory issues. Attendees will have an opportunity to ask questions of the NRC staff or make comments about the issues discussed following the business portion of the meeting; however, the NRC is not actively soliciting comments towards regulatory decisions at this meeting.

Purpose: The purpose of the meeting between the U.S. Nuclear Regulatory Commission (NRC) and Duke Energy Progress, LLC (Duke) is to discuss a proposed license amendment request for Shearon Harris Nuclear Power Plant, Unit 1 (HPN), to modify HNP Technical Specification (TS) 3/4.7.5, "Ultimate Heat Sink," by relocating the minimum water level limits to the licensee-controlled Technical Requirements Manual. The proposed amendment would also update the TS to reflect that either the Auxiliary Reservoir or the Main Reservoir, when operable, meets the associated Limiting Condition for Operation. In addition, an administrative change is proposed to consolidate content from TS Table 6.2-1, "Minimum Shift Crew Composition," related to the responsibility of the individual designated for the control room command function, into TS 6.1.2.
