**Comments:** Section 5 of EO 14300 directed the NRC to undertake a review and wholesale revision of its regulations and guidance documents, and issue notices of proposed rulemaking effecting this revision within 9 months [February 23, 2026] and issue final rules and guidance to conclude this revision process within 18 months [November 23, 2026]. This meeting is one of several public meetings being conducted by the NRC related to this effort.
