
Subject: Submittal of Decommissioning Plan for the Plum Brook Reactor Facility

The National Aeronautics and Space Administration (NASA) hereby submits the enclosed report entitled, "Decommissioning Plan For The Plum Brook Reactor Facility." This report is provided in accordance with 10 CFR 50.82(b) and the guidance in NUREG 1537 for the radiological remediation and license termination of the Plum Brook Reactor Facility (PBRF), which consists of NASA Plum Brook Reactor, License No. TR-3, Docket 50-30 and NASA Plum Brook Mock-Up Reactor, License No. R-93, Docket 50-185.

Appendix D of the enclosed report is the cost estimate by principal task for decommissioning the PBRF. This information is provided only for the purpose of the Nuclear Regulatory Commission's (NRC) review and approval of the PBRF Decommissioning Plan, and is considered by NASA to be pre-decisional (Ref. 5 USC §552(b)(5) and 10 CFR §2.790(a)(4) and (a)(5)). Distribution should be limited to official government purposes only. Accordingly, it is respectfully requested that any request for access to the enclosed under the Freedom of Information Act be referred directly to NASA for response.
