Purpose of Meeting: The Open House portion of the meeting will provide a forum where U.S. Nuclear Regulatory Commission (NRC) staff will be available to discuss agency activities and nuclear power issues with the public. During the Open House, the NRC staff will be available to discuss issues specific to Palisades, including a recent license amendment request (LAR) associated with pressurized thermal shock (PTS), a White finding in the area of radiation protection identified in the fourth quarter of 2014, and the results of an assessment of the Safety Conscious Work Environment (SCWE) in the Security department. As part of a public outreach effort, The Division of Nuclear Materials Safety (DNMS) will also be on hand at the Open House to discuss the NRC's regulation of radioactive materials in non-nuclear reactor applications.
