Purpose: This is a pre-application meeting between Tennessee Valley Authority (TVA) and the Nuclear Regulatory Commission staff to discuss a proposed LAR to cross-tie chilled water from the Browns Ferry Unit 3 Control Bay Chiller System to the supply and return chilled water piping for the Browns Ferry Units 1/2 Control Bay Chiller System. The proposed modification provides an alternate cooling source and reduces the potential for a three-unit shutdown when the Browns Ferry Units 1/2 control bay chillers are inoperable.
