Purpose: The purpose of this meeting is to allow NRC, industry, and public stakeholders to discuss NEI (Nuclear Energy Institute) Draft 18-07, "Licensee Performance Assessments, Methodology for Licensee Identification of Latent Design Issues." Implementation of this guidance would allow power reactor licensees to take credit for specific NRC inspections by performing self-assessments. NRC staff will discuss their review of the NEI draft guidance, and industry will provide an overview of their plan. NRC will also provide an update of the selection of topics for Focused Engineering Inspections by its Engineering Inspection Working Group.
